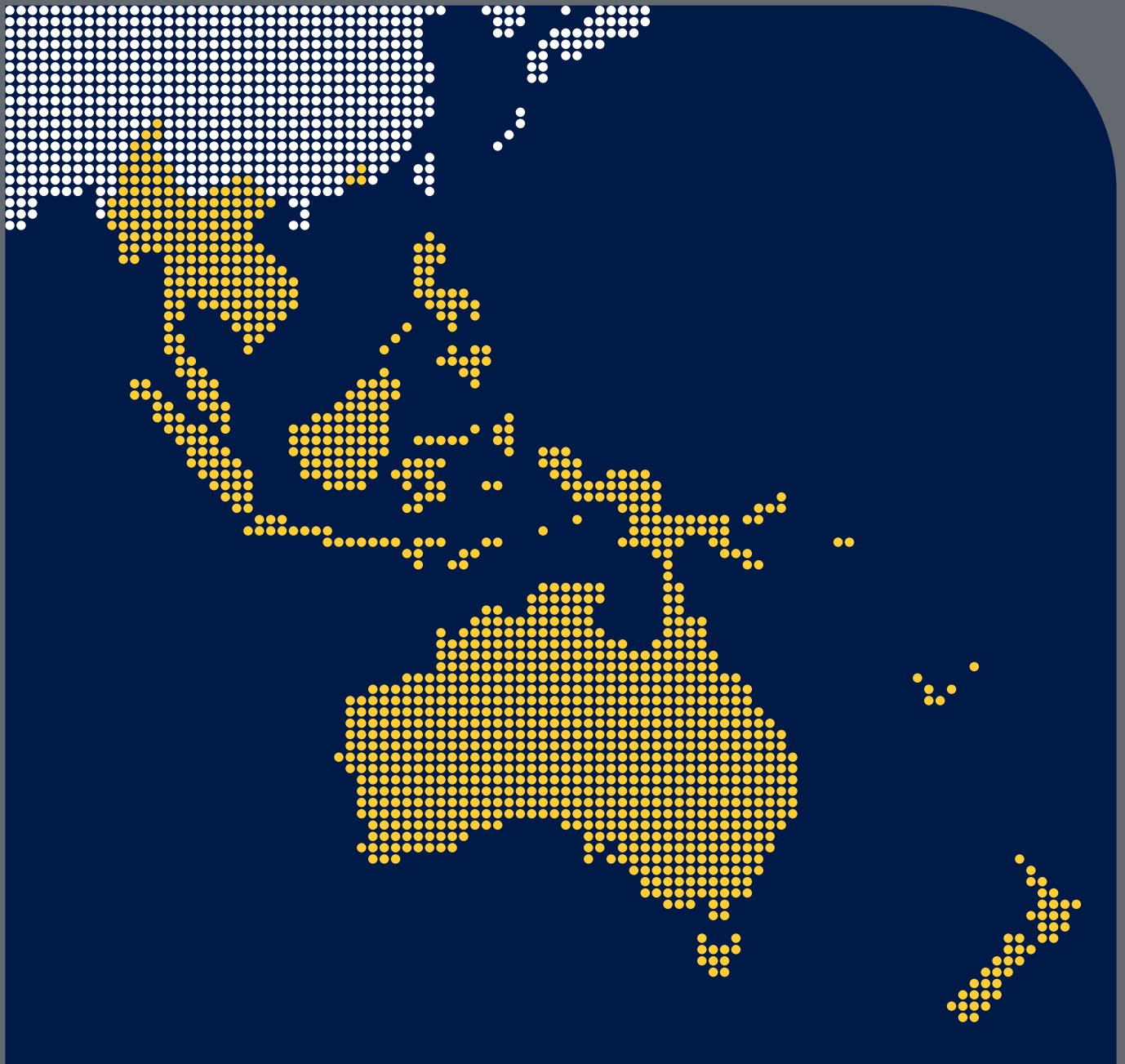

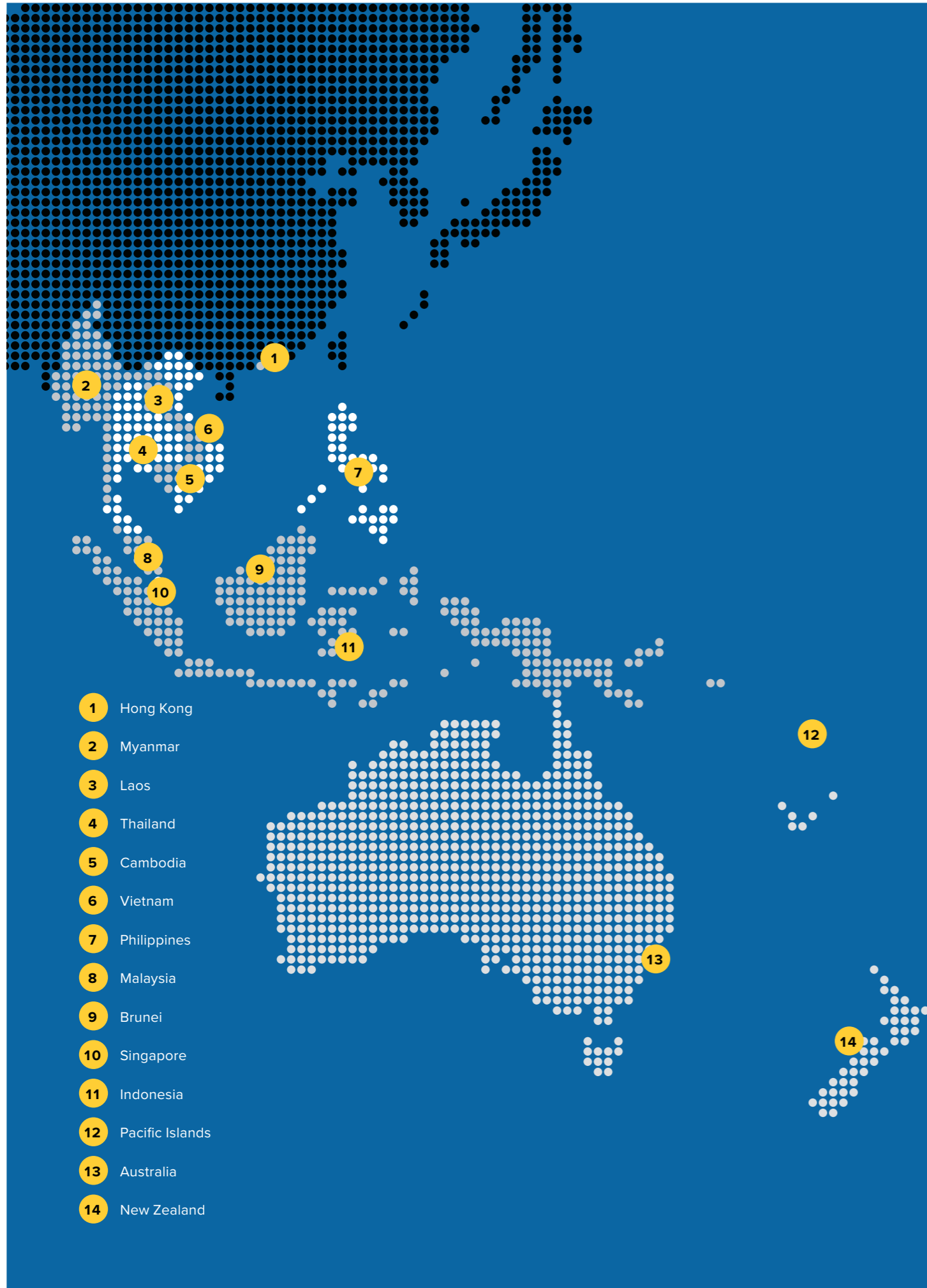

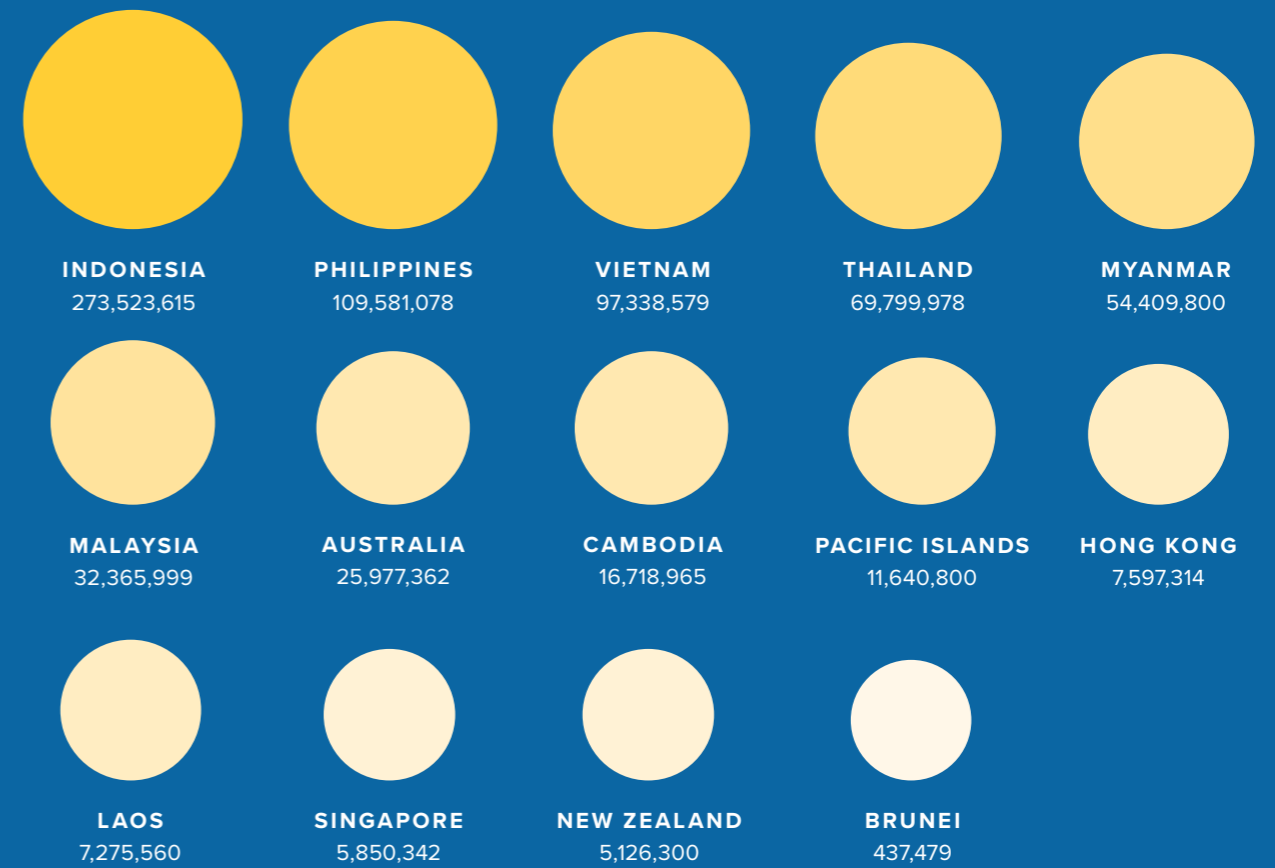

ASSOCIATION OF SOUTH EAST ASIAN NATIONS (ASEAN)

- Membership: Indonesia, Malaysia, Philippines, Singapore, Brunei, Cambodia, Laos, Myanmar, Thailand, Vietnam
- The ASEAN Declaration was signed in 1967 with parties committing to political, economic and socio-cultural stability and security. The declaration provides for rules based economic integration, with a focus on market economy principles and multi-lateral trade rules to eliminate barriers to regional economic trade.

REGIONAL COMPREHENSIVE ECONOMIC PARTNERSHIP (RCEP)

- Membership: Australia, New Zealand, Brunei, Cambodia, China, Japan, Laos, Singapore, Thailand, Vietnam.
- Entering into force on 1 January 2022, the RCEP established a modern and comprehensive free trade platform in respect of goods, services, investment, economic and technical cooperation. The partnership promotes adherence to the World Trade Organisation rules and aims to facilitate e-commerce through enabling an environment for businesses to trade digitally in the region and support consumer confidence in the online environment.

REGIONAL FREE TRADE AGREEMENTS

- In addition to the RCEP, there are many free trade agreements across jurisdictions in South East Asia and Oceania. For example, Australia has been active in driving the free trade discussion and has bi-lateral free trade agreements with New Zealand, Singapore, Thailand, Malaysia, South Korea, Japan, China, Hong Kong and Indonesia. The active Government engagement in trade liberalisation provides businesses with significantly greater certainty and market access.

PACIFIC AGREEMENT ON CLOSER ECONOMIC RELATIONS PLUS (PACER PLUS)

- Membership: Australia, New Zealand, Samoa, Kiribati, Tonga, Solomon Islands, Niue, Cook Islands, Nauru*, Tuvalu*, Vanuatu*
*(*membership awaiting ratification)*
- PACER PLUS entered into force on 13 December 2020, bringing the Pacific Island countries into closer economic relations with Australia and New Zealand. The agreement aims to provide a stable, secure and prosperous region with open and transparent policy developments and greater engagement.

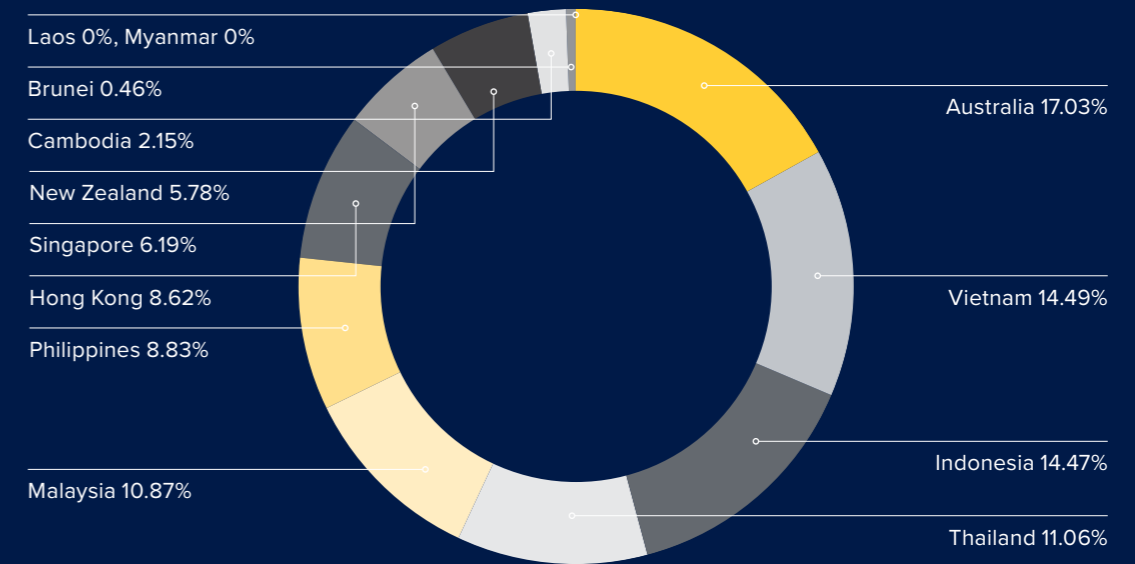

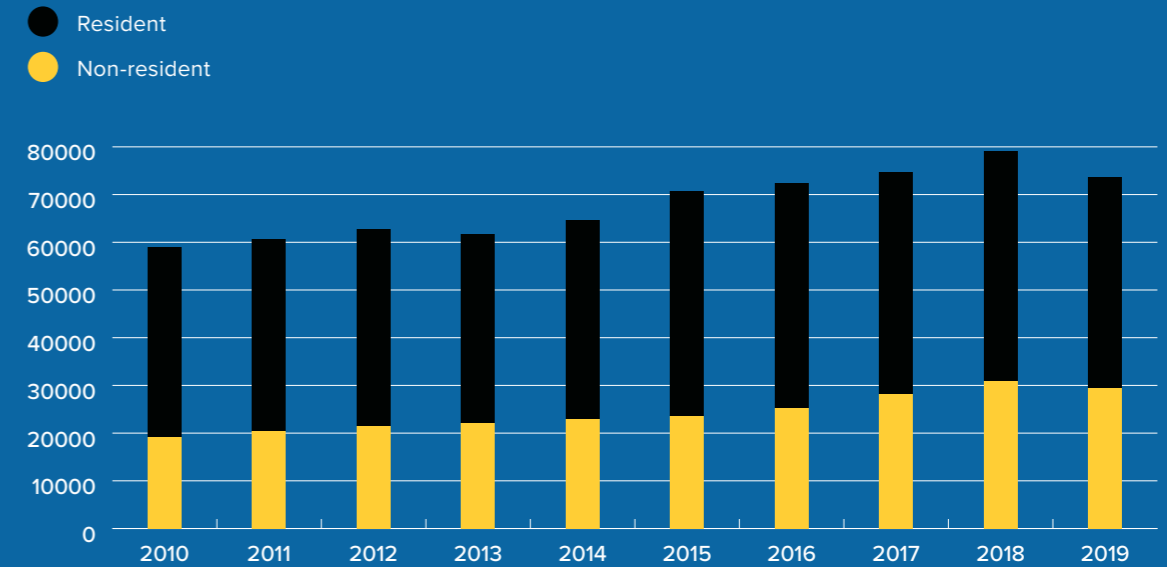

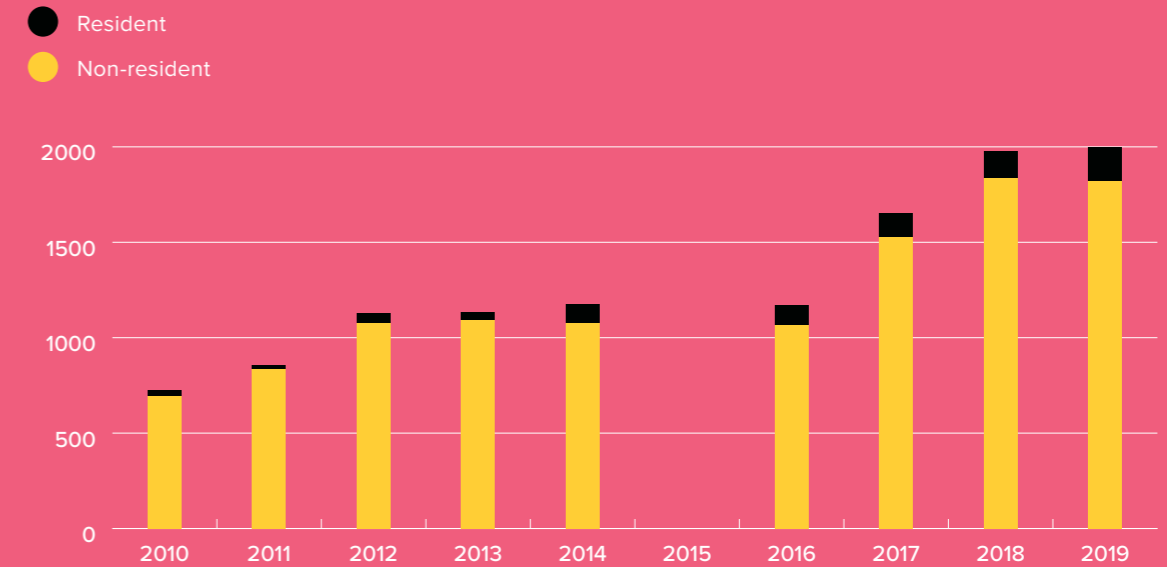

Depending on the nature of the mark some further information may be required including:

- Specimens of the mark in jpeg format for device marks
- Details of colour claim
- Description of mark, applies to:
 - shape marks - a description of the shape mark and its features
 - colour marks - a description identifying the specific colours (for example using pantone colour numbering)
 - sound marks - a representation of the sound which may be presented as a musical score or a sample audio file
 - the written description of each of these types of marks must be sufficiently precise and clear to define the mark, in order to secure a filing date

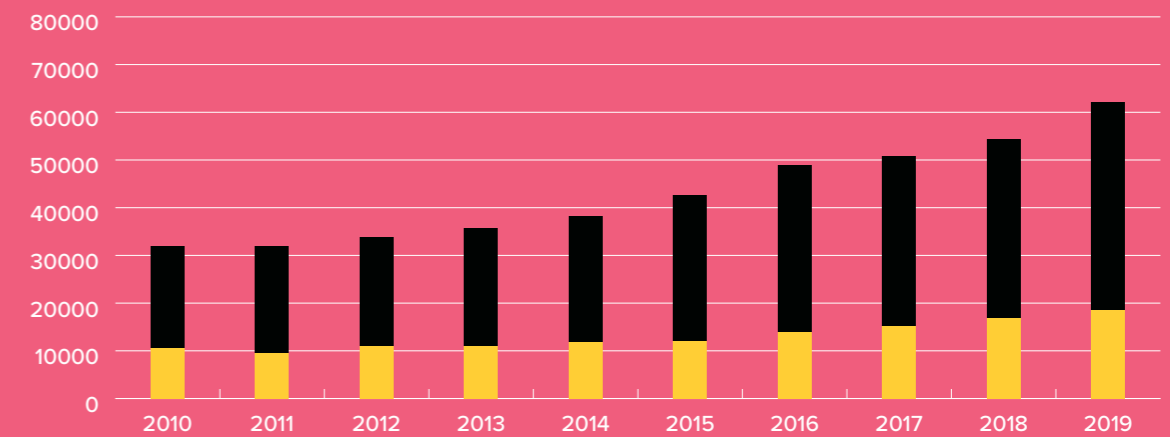
