





### STRONG ECONOMIC OUTLOOK


- In 2020 ASEAN registered growth of US\$70 billion in greenfield investments.
   It was the biggest such FDI inflow of any developing world region.
- In 2016 the region's annual average GDP growth was 4.6 per cent outpacing the global average of 3.2 per cent.\*
- The ASEAN combined GDP (as a single economic entity) is currently around US\$2.5 trillion and taken as a whole the region is set to become the equivalent of the world's fourth largest economy by 2030.\*
- As evidenced by the surge in locally originating patent fillings large multinational firms are looking to take advantage of the favourable economic conditions for manufacturing and R&D in ASEAN countries.

### **ESTABLISHED PATENT SYSTEMS**

- All ASEAN countries (except Myanmar) are members of the Patent Cooperation Treaty. Cambodia recently became a member of the PCT and has been bound by the PCT system since 8 December 2016. Myanmar provides IP protection.
- The ASEAN countries (except Myanmar) have well developed patent legislation.
- Strong development of IP examination procedures, specialised courts and enforcement procedures. This has led to a rapid increase in patent filings in the region.

### **PPH & ASPEC**

Examination in the ASEAN countries can be relatively straight forward using Patent Prosecution Highway (PPH),
 ASEAN Patent Examination Co-operation (ASPEC) program or, if a corresponding application has been allowed in major jurisdiction such as the United States, Japan, Europe, or Australia.




### **ASIA PACIFIC PATENT FILINGS 2019**


### **No Patent System**
